

REGIONAL ARTS DEVELOPMENT FUND (RADF)

The Regional Arts Development Fund (RADF) is a partnership between state and local governments which invests in quality arts and cultural experiences across Queensland, based on locally determined priorities.

RADF promotes the role and value of arts, culture and heritage as key drivers to -

- Support diversity and inclusivity;
- Grow strong regions; and
- Provide training, education and employment opportunities for Queensland artists and local communities.

Since 2015, Councils now deliver locally tailored RADF programs based on the identified priorities, opportunities and capacities of their local communities. This means that RADF may look different place to place as to best respond to the ways of working and aspirations of local communities.

OBJECTIVES

The RADF objectives are to:

1. Support local artists and arts and cultural activity to deliver value for local communities
2. Provide opportunities for local communities to participate in arts and cultural activities
3. Invest in locally-determined priorities delivered through arts and cultural activity
4. Contribute towards current government priorities

KEY PERFORMANCE OUTCOMES (KPOS)

All projects receiving RADF funding are required to report on their contribution towards the Key Performance Outcomes (KPOs):

IMPACT

1. RADF invests in a diversity of local arts and cultural projects
2. RADF engages in local communities in arts and cultural activities

RADF IN SOMERSET

From 2015, Councils will have more flexibility to create and deliver a locally-relevant RADF program to ensure the program creates valuable outcomes for local communities and continues to deliver quality arts experiences and supports a strong and sustainable arts and cultural sector.

Somerset Regional Council is committed to promoting the arts as a tool for cultural expression, place making, development and encouraging cultural engagement and participation to build community capacity.

Through four funding rounds, RADF will work in conjunction with the Somerset Regional Council Arts and Cultural Policy to realise three main priorities. It is envisioned that these priorities are addressed in the project description of all RADF applications.

STRATEGIC PRIORITIES

Each year three themes / priorities are identified which align themselves with Councils Corporate Plan. The priorities are:

- Young people
- Tourism
- Vibrant towns and villages

70% of RADF funds will be linked directly to these three priorities with 30% of RADF funds to be used to promote artistic excellence through the:

- Artist in residence program
- Professional development program.

GRANT CATEGORIES

RADF grants are available for individuals, groups and organisations. The funding categories below outline the eligible activities and projects. Your application must align with one of these categories.

STRATEGIC THEME 1: YOUNG PEOPLE

This theme aims to support young individual professional and emerging artists or arts and cultural workers living in the Somerset Region and encourage growth in their practice.

This strategic priority is about creating activities, events and experiences with four outcomes we would like young people to experience:

- For young artists to enrich our communities, be empowered to take risks, be innovative and make statements.
- Enable young people to have access to pathways and development opportunities that help them make a living from their work.
- Encourage young people from different cultures to come together to create fresh, edgy music, dance, performance and art that reflect Somerset's youthful enthusiasm for new experiences.
- Enable young people to have access to, and enjoy, a wide variety of arts and cultural activities, events and festivals in both traditional and alternative spaces and venues.

Applications will support the participant to grow and excel in their chosen field of practice.

STRATEGIC THEME 2: TOURISM

This theme supports projects which make cultural life visible within the Somerset region through creating place based cultural activities which will develop the regions cultural heritage and help promote cultural tourism.

This might be through but not limited to:

- The development of public art and inclusion with our infrastructure and public spaces.
- The provision of public events, exhibitions and performances.
- Cultural tourism; projects encouraging visitors to appreciate our culture.

- The development and strengthening of our cultural tourism assets such as museums, galleries, cemeteries and historical sites.
- Projects encouraging collaboration and partnerships within local arts and non-arts organisations.

STRATEGIC THEME 3: VIBRANT TOWNS AND VILLAGES

The Somerset region is home to an array of communities, each of which has a distinct personality and history. This priority is about creating a sense of place in our towns and villages which respects and highlights their heritage and character. Projects that bring our towns and villages alive through events, activities and celebration are encouraged.

Ideas may include but not be limited to:

- Development of public precincts and places
- Interpretation of place and local stories
- Cultural animation and cultural programming, including festivals and public events

ARTISTS IN RESIDENCE PROGRAM

Artists in Residence programs offer an opportunity for artists to have time to dedicate to their artwork; to grow and expand ideas, to take their creativity to a new level of excellence.

Artists in Residence programs can grow the skills of the art community in a given area through inviting an artist to expand local skills in a chosen art form, share the artists experience and expertise, provide an artist to work with the community and focus attention on art in general.

An artist in residency program can benefit a place or community through association, interaction and as a source of inspiration. It is not confined to any particular art form. It is not confined to a length of time or type of working space.

PROFESSIONAL DEVELOPMENT PROGRAM

This priority is for individual artists and cultural workers (emerging and established) to participate in transformational professional and career development opportunities.

The main objectives of this program are to:

- Propel careers to the next level of professionalism.
- Develop new skills and knowledge.
- Develop new markets and new audiences for new work.
- Offer significant and inspirational opportunities for professional development.
- Develop and expand industry networks.
- Contribute to the local community through sharing skills and knowledge.
- Explore new directions in arts or cultural practice.

APPLICATION PROCESS

RADF applications involve a two stage process.

The first stage is the Project Snapshot which involves the submission of a two page project outline and budget. If the project meets the RADF guidelines, applicants will be advised to complete the stage two application form.

1. Stage one - Proposal snapshot
2. Grant applications will be checked for eligibility by the RADF liaison officer.
3. Stage two application forms must be submitted - projects are shortlisted
4. Applications will be assessed by the RADF committee. The committee will consider:
 - Key Performance Outcomes
 - Eligibility
 - Available funding
 - Funding multiple art forms
 - Project locations
 - Project alignment with local priorities and corporate documents such as the Arts and Cultural Policy and Corporate Plan.
5. The RADF committee will create a funding recommendation.
6. Recommendation goes to Council meeting to be approved
7. Applicants will be advised of funding outcome.
8. All applicants are encouraged to seek feedback on their application.

HOW MUCH CAN I APPLY FOR?

Individual project requests will not be capped and will be assessed on merit. RADF will not support 100% of any project.

All RADF funding will be assessed by the RADF advisory committee consisting of community members. The committee will consider the grants against the assessment criteria and make funding recommendations which will then be ratified by Council.

APPLICANT ELIGIBILITY

INDIVIDUALS

- Individual professional artists, emerging artists, arts workers, cultural workers and/or project coordinators
- Must be permanent residents or Australian citizens

GROUP/UNINCORPORATED BODY

Collectives or cooperatives are community groups or groups of artists that are not incorporated but must be auspiced by an incorporated organisation including local government, or an individual with an ABN. One person must be nominated as the accountable representative of the collective for management, reporting and financial matters.

ORGANISATION

Eligible organisations include arts and cultural not-for-profit organisations and Australian companies that are either based in Queensland or able to demonstrate how their project will directly benefit Queensland arts and culture.

Organisations must be registered under law as either incorporated associations or a company limited by guarantee.

ALL APPLICANTS MUST:

- Have successfully acquitted previous RADF grants
- Complete application in entirety
- Include essential support material
- Sign application (applicants under 18 must have a guardian co-sign application)
- Submit application by 5pm on the round due date (or be time-stamped if in post)
- Have an ABN (or be auspiced by individual/ organisation with ABN)
- Be based in the Somerset region or if based outside the region, applicants must demonstrate how the project will directly benefit arts and culture in the Somerset region.
- Have discussed their project with the Somerset Regional Council RADF liaison officer.

INELIGIBLE PROJECTS AND ITEMS

- Applications seeking 100% of project funding. Applicants are required to make a significant contribution to their projects, this may be in-kind.
- Projects which pay arts workers below industry recommended rates.
- Projects which have already commenced (RADF does not 'top up' funds)
- Recurrent funding for arts organisations operational expenses. However, local arts and cultural organisations may apply for funding for additional projects beyond their normal capacity.
- Recurrent funding: the same activity or project will not be funded multiple times. Applicants are eligible to apply for RADF funding for projects which build on their previous projects.
- Capital expenditure: except where equipment is directly essential to the project, the equipment remains available to the local community and the future process or handling equipment is identified in initial RADF proposal. The RADF committee must consider the purchase integral to that project.
- Prize money for competitions and eisteddfods. RADF will fund bringing in professionals to our region to assist with your event, such as judges and associated costs, providing those professional offer a public program (i.e. talk or workshop) to provide a community benefit alongside their duties.
- Primary training of artists: accredited study, training or university courses.
- Framing
- School arts activities EXCEPT where those activities form part of broader community cultural development processes or are part of professional arts development.
- Summer/ Winter schools: A maximum of two places will be supported each year.
- Freight: only a small proportion of these costs can be covered as part of presentation costs for significant exhibitions.
- Publishing costs projects incorporating publication of a document should consider other sources of funding for this aspect, or utilise print-on-demand services. A maximum portion of costs may be eligible as part of the presentation of significant projects, as a guide 25%. This decision is at the RADF Committee's discretion.
- Entertainment: funding is not available to pay for entertainment at events. However, it may be considered if there is an additional community benefit i.e. a performing musician also runs a series of workshops.
- Murals: Murals will only be funded if they align with the funding categories and assessment criteria.
- Workshops with arts and cultural service organisations that are part of the organisations 'core' business. Arts QLD have already funded these organisations to deliver core services.
- Amateur arts activities and craft: except where a professional artist or arts worker is employed to provide professional services or encourage innovation and arts development.

ACKNOWLEDGEMENTS, REPORTING AND ACQUITTAL PROCESSES

NOTIFICATION OF OUTCOME

All applicants will be notified of their application outcome in writing shortly following the dates listed with grant round information.

Successful applicants will receive two copies of a RADF letter of offer (any special conditions will be listed) -

- One to sign and return
- One to keep for your reference

CHANGES TO YOUR PROJECT

It is understandable that sometimes the proposed RADF project cannot go to plan and changes need to be made. When this happens, please ensure you -

- Notify the RADF Committee (via email to the RADF Liaison Officer) prior to commencing any changes to your activity.
- Use the form provided to state the reason for the change and list the proposed amendment to the project such as timeline, budget, etc.
- Await RADF Committee decision.

The RADF Committee may:

- Approve the changes
- Request you complete a new application form or budget
- Ask you to return the funds and re-submit your application in the next round

You must:

- Action any requirements requested by the committee
- Keep a record of your change request to submit with your outcome report.

COMPLETION OF YOUR PROJECT

- An Outcome report is due no more than eight weeks after the completion of your RADF project.
- Any unspent moneys will need to be returned. The RADF Liaison Officer will confirm the amount with the applicant and provide details for payment at the acceptance of the Outcome Report.
- The applicant will be notified in writing that their Outcome Report has been accepted. They are now eligible to apply to RADF again.
- Applicants who fail to submit Outcome Reports will be ineligible to apply for future funding and may be asked to repay the grant.

It is recommended that the Outcome Report is read upon starting your project so you can identify what information you will be required to collect during your project.

UNSUCCESSFUL APPLICATIONS

All applicants will be notified of their application outcome in writing following the dates listed with grant round information.

Unsuccessful applicants are encouraged to contact the RADF Liaison Officer to gain feedback and advice on their application. Feedback can be used to strengthen your application for re-submission in future grant rounds.

DISPUTE RESOLUTION

If any conflict arises between applicants and Committee Members or Council staff, you should first contact the RADF Liaison Officer regarding any disagreement.

You have the right to request a meeting with a Committee Member or Council staff to get feedback on your application or see the minutes of assessment meetings.

Arts Queensland can offer advice about the RADF Program to you and the Committee, but it is not available to mediate. However, the Local Government Association of Queensland can suggest local mediators.

ACKNOWLEDGEMENT

RADF funded activities must acknowledge the Queensland Government and Somerset Regional Council in all promotional material, publications and products by inclusion of RADF acknowledgement text and logos - as provided to you by Somerset Regional Council.
