**Making of subordinate local laws**

1. Somerset Regional Council (the “Council”) has, by resolution dated the 22<sup>nd</sup> day of April 2015, made each of —
  - (a) *Subordinate Local Law (Repealing) Subordinate Local Law (No. 1) 2015*;
  - (b) *Subordinate Local Law No. 1.6 (Operation of Camping Grounds) 2015*;
  - (c) *Subordinate Local Law No. 1.8 (Operation of Caravan Parks) 2015*;
  - (d) *Operation of Temporary Entertainment Events (Amendment) Subordinate Local Law (No. 1) 2015*;
  - (e) *Animal Management (Amendment) Subordinate Local Law (No. 1) 2015*; and
  - (f) *Parking (Amendment) Subordinate Local Law (No. 1) 2015*.

**Subordinate local laws amended**

2. The subordinate local laws identified in paragraph 1(d), (e) and (f) amend existing subordinate local laws as follows—
  - (a) *Operation of Temporary Entertainment Events (Amendment) Subordinate Local Law (No. 1) 2015* amends *Subordinate Local Law No. 1.12 (Operation of Temporary Entertainment Events) 2011*;
  - (b) *Animal Management (Amendment) Subordinate Local Law (No. 1) 2015* amends *Subordinate Local Law No. 2 (Animal Management) 2011*; and
  - (c) *Parking (Amendment) Subordinate Local Law (No. 1) 2015* amends *Subordinate Local Law No. 5 (Parking) 2011*.

**Subordinate local laws repealed**

3. *Subordinate Local Law (Repealing) Subordinate Local Law (No. 1) 2015* repeals each of —
  - (a) *Subordinate Local Law No. 1.6 (Operation of Camping Grounds) 2011*; and
  - (b) *Subordinate Local Law No. 1.8 (Operation of Caravan Parks) 2011*.

**Authorising local law**

4. Various local laws authorise the making of the subordinate local laws identified in paragraph 1 as follows—
  - (a) *Local Law No. 1 (Administration) 2011* authorises the making of each of —
    - (i) *Subordinate Local Law (Repealing) Subordinate Local Law (No. 1) 2015*; and
    - (ii) *Subordinate Local Law No. 1.6 (Operation of Camping Grounds) 2015*; and
    - (iii) *Subordinate Local Law No. 1.8 (Operation of Caravan Parks) 2015*; and

- (iv) *Operation of Temporary Entertainment Events (Amendment) Subordinate Local Law (No. 1) 2015*; and
- (b) *Local Law No. 2 (Animal Management) 2011* authorises the making of *Animal Management (Amendment) Subordinate Local Law (No. 1) 2015*; and
- (c) *Local Law No. 5 (Parking) 2011* authorises the making of *Parking (Amendment) Subordinate Local Law (No. 1) 2015*.

### **Purpose and general effect**

5. The purpose and general effect of each subordinate local law identified in paragraph 1 is as follows—
- (a) *Subordinate Local law (Repealing) Subordinate Local Law (No. 1) 2015* repeals each of *Subordinate Local Law No. 1.6 (Operation of Camping Grounds) 2011* and *Subordinate Local Law No. 1.8 (Operation of Caravan Parks) 2011*; and
  - (b) *Subordinate Local Law No. 1.6 (Operation of Camping Grounds) 2015* regulates the operation of camping grounds;
  - (c) *Subordinate Local Law No. 1.8 (Operation of Caravan Parks) 2015* regulates the operation of caravan parks;
  - (d) *Operation of Temporary Entertainment Events (Amendment) Subordinate Local Law (No. 1) 2015* amends *Subordinate Local Law No. 1.12 (Operation of Temporary Entertainment Events) 2011* by regulating the operation of temporary entertainment events;
  - (e) *Animal Management (Amendment) Subordinate Local Law (No. 1) 2015* amends *Subordinate Local Law No. 2 (Animal Management) 2011* by prohibiting the keeping of specified animals, prescribing minimum standards for the keeping of animals and identifying dog off-leash areas; and
  - (f) *Parking (Amendment) Subordinate Local Law (No. 1) 2015* amends *Subordinate Local Law No. 5 (Parking) 2011* by identifying off-street regulated parking areas.

### **Anti-competitive provision**

6. An anti-competitive provision is contained in each of—
- (a) *Subordinate Local Law No. 1.6 (Operation of Camping Grounds) 2015*;
  - (b) *Subordinate Local Law No. 1.8 (Operation of Caravan Parks) 2015*; and
  - (c) *Operation of Temporary Entertainment Events (Amendment) Subordinate Local Law (No. 1) 2015*.

### **Consolidated version of subordinate local laws**

7. Council has, by resolution dated the 22nd day of April 2015, adopted a consolidated version of each of —
- (a) *Subordinate Local Law No. 1.12 (Operation of Temporary Entertainment Events) 2011*;
  - (b) *Subordinate Local Law No. 2 (Animal Management) 2011*; and
  - (c) *Subordinate Local Law No. 5 (Parking) 2011*.

## **Inspection**

8. Copies of each subordinate local law identified in paragraph 1 and each consolidated version of a subordinate local law identified in paragraph 7 may be—
  - (a) inspected and purchased at Council’s public office at 2 Redbank Street, Esk; and
  - (b) viewed by the public on the website of the Department of Local Government.
