## Cr Hall - Matters of public interest -

## Cr Choat - Matters of public interest -

Cr Choat commented that the current issue of fires in the region is a serious matter of public interest. The region has black parched areas of grasslands and road reserves. Cr Choat commented that a vast majority of these fires appear to start from the road reserve, and people need to think seriously about this and not throw cigarette butts from vehicles when travelling.

## Mayor Lehmann - Matters of public interest -

The Mayor comment that the Reel Fishing Competition held last weekend was one of the best family days he has attended in the region for a long time, and would like to see this event happen again. Everyone at the event seemed to be happy about how it went, and the



money that has gone back to the Fish Stocking Association has grown to over \$1,500. Cr Lehmann commented that the people who won the boat, then sold the boat and gave some of the money back to the Fish Stocking Association. The Mayor thanked everyone who was involved, as it was a real success, with good fish caught. There was a world record set for the biggest Bass caught in Somerset Dam last weekend as well. It was a weekend for good fishing.

## **Background/Summary**

It is with pleasure that I provide the following summary of the Natural Resource Management Officer activities for July 2018:

#### Land for Wildlife

- Preparations are underway to celebrate 20 years of the Land for Wildlife program in South East Queensland with a joint Local Government workshop at Minden, with adjoining Local Governments, Lockyer Valley Regional Council, and Ipswich City Council. The anticipated event date is September 22, and will include a property visit, wildlife experience show, and opportunity for members of the program to network across the Council boundaries.
- On the July 14, Land for Wildlife participants visited the Queensland Herbarium in the
  first of two workshops relating to Queensland Flora and Fauna records. The event
  was well attended, and enjoyed a presentation from Herbarium director Dr Gordon
  Guymer, and a tour of the Herbarium facility.
- Preparations continue for the next Somerset, Land for Wildlife workshop to be held at the Queensland Museum in October. This workshop will allow participant to visit the behind the scenes area of the museum and experience the specimen collection, and learn how members can provide specimens, or use the reference collection for identification purposes.
- Somerset welcomed 1 new Land for Wildlife property to the program in July at Harlin.

## Somerset Flora and Fauna

- Tree clearing was undertaken in the Linville township on the 16-17 July to reduce the opportunity for Flying Foxes to roost around and over dwellings in this location. Approximately 10 Roost trees were removed from Council managed lands with the intention that the removal will persuade the returning Flying Foxes (in Spring) to roost in trees remaining that are further from residential dwellings, or to relocate to the alternate Roost site at Greenhide Reserve, approximately 2 km south of the Township.
- Council was alerted to a burn that was undertaken at Lowood under the existing Flying Fox Roost on the 22<sup>nd</sup> of July. As this Roost is not located on Council owned or managed land, the matter has been referred to Queensland Fire and Emergency Services, and the Department of Environment and Science for further investigation.



- Tree clearing and trimming was undertaken on July 6 at Minden adjacent to Minden Lagoon to provide a buffer between existing wildlife habitat, and the adjacent road. This action was primarily in response to the periodic visitation of Cattle Egrets that nest in the reserve in large numbers. Council has also implemented addition Wildlife signage along the road, and planted additional trees around the lagoon further away from potential road impact/s.
- Attendance at Department of Environment and Science "Koala Collaboration" at Lone Pine Koala Sanctuary on July 19. This event highlighted some of the current and emerging science regarding Koala conservation consideration/s, with a particular focus on health and associated stressors.
- Council has received representation from Ipswich Koala Protection Society regarding Koala road related injuries along Hine Road, Dundas (Accessing Billies Bay and Hays Landing SEQ Water Reserves). Officers are facilitating discussion and undertaking investigation regarding mitigation measures with partner organisations.

## **Catchment Management**

- Work is underway to provide delivery arrangements for Resilient Rivers funding that
  has been awarded to Somerset Regional Council for delivery in the Mid Brisbane
  River Catchment. A meeting was held with Regional Partners to discuss collaborative
  delivery models on the July 23, and draft documentation and project agreements are
  being progressed. Council will collaboratively deliver:
  - o ~\$120,000 for Black Snake Creek rehabilitation
  - \$105,000 for Recreational investigation of Hills Crossing and Savages Crossing (funding and delivery – in association with SEQ Water engineering design/s)
  - \$85,000 Landholder incentive program with SEQ Water lead, (Somerset Regional Council is a project oversight committee representative)
- The delivery of the Mid Brisbane River On-site Wastewater Risk Mitigation Program (review of Septic systems along the Mid Brisbane Catchment) is ongoing, with the inspection program now complete, and preparation of a final report underway. Officers will be meeting with SEQ Water to discuss the results and the potential next steps in a further role out and/or incentive program to improve system best practice where possible.

## **Fire Considerations**

- A meeting was undertaken with Queensland Fire and Emergency Services staff in respect of a controlled burn and risk assessment program for the Jimna Township. Council has committed to an ongoing presence in these discussions with other key stakeholders to achieve the best collaborative result possible.
- Undertaking a review of the application of Council Policy OP 14 Hazard Reduction Burn Policy in respect of customer and Administrator (QFES) feedback.

## **Collaborations**

 Council continues to support the Kilcoy State High School Agricultural studies students to undertake practical assessment and general maintenance elements at

Hopetoun Fields, Kilcoy. Given the success of this model, similar collaborations are being investigated between other Somerset school program/curriculum elements, and local reserve management.

## **Background/Summary**

In delivering on the themes identified in Council's current Operational Plan, it is with pleasure that we submit a synopsis of the section's activities during the month of July 2018.

#### **Invasive Animal Control -**

The following is a summary of pest animal control activities for the month:

#### Wild dogs -

• **1080 Baits injected: 815.** The next advertised 1080 baiting program day will be held on the 10 September 2018.

#### Rabbits -

- Officers have been working with landholders to control rabbit infestations in the following areas; Mount Beppo, Hazeldean, Linville, Toogoolawah.
- Officers are continuing to work closely with Seqwater in controlling rabbits around Somerset Dam and Wivenhoe Dam.

## Feral Pigs -

 Officers have been working with Seqwater in controlling pigs around Wivenhoe Dam; one boar was trapped this month.

#### **Invasive Plant Control -**

A summary of pest plant and other vegetation treatment activities for the month is as follows:

• Fireweed - Neurum, Fernvale, Mount Tarampa, Sandy Creek, Glamorgan Vale,

- Clarendon, Mount Kilcoy, Lowood, Wivenhoe Pocket, Esk and Atkinsons Dam.

## **Background/Summary**

Council has received correspondence from Ipswich City Council containing a proposed motion to the 2018 Annual LGAQ Conference in relation to the *Animal Management Act 2008* and a request for the support of other SEQ Councils.

The motion proposes that the LGAQ advocate to the State Government for changes to the *Animal Management Act 2008*, to allow the use of compliance notices (and associated seizure/disposal powers) for the following offences:

- Chapter 2 Identification of cats and dogs.
- Chapter 2A Registration of dog breeders and related matters.
- Chapter 2B Supply of cats and dogs.
- Chapter 3 Dog Registration.

The proposed amendments will address issues such as where Council can infringe an owner for an offence, but cannot take meaningful action beyond that to stop the activity/offence from continuing.

Subject: Major Amendment to Somerset Region Planning Scheme -

deciding to make an amendment

### **Background/Summary**

The Somerset Region Planning Scheme commenced on 1 March 2016, since this time it has been used to assess and guide development across the region. The planning scheme has been amended twice since its adoption, firstly to align with the *Planning Act 2016* and then to incorporate the Local Government Infrastructure Plan and related Planning Scheme Policy 4 – Design Standards. To ensure the planning scheme remains consistent with current legislation and to improve the functionality of the scheme it is proposed to undertake a major amendment. As per the Ministers Guidelines and Rules (MGR), to make a major amendment, the local government must first decide to amend the planning scheme

This major amendment will represent a combination of changes which have resulted from policy adjustments by Council and the State, general improvements to the scheme, being readability as well as correcting errors identified following implementation of the scheme.

The amendment process is lengthy and includes a State Interest review and public consultation. The State Interest review is anticipated to take a minimum of 60 business days and the public consultation about 30 business days. With this in mind, it is expected that the amended planning scheme be adopted by Council in mid 2019.

## **Background/Summary**

Council at its Ordinary Meeting of 12 August 2015 approved a development application for a Material Change of Use for a Multiple Dwelling (56 units over 14 stages) situated at 449 Lowood Minden Road, Tarampa, described as Lot 4 on RP138581 and known as Tarampa Lodge.

Council has now received representations from the applicant requesting to amend the carparking arrangements provided for the development and is seeking ·Council's confirmation that the amended plan is considered generally in accordance with the approved plan.

The proposed changes are illustrated at Attachment 1 and are as follows:

- 1 less carpark in front of the office
- 21 additional carparks in the first area on the northern side of the entry driveway
- 6 less car parks on the driveway south of stage 3
- Overall increase of 14 car parks.

Council's Development Design Manager has reviewed the proposed changes and has advised that he has no issues as more than the minimum 30 carparks (including two (2) disabled carparks) are being provided which is consistent with the conditions of development.



As the proposed changes to the carparking layout are considered to be minor it is further considered that the requested change can be considered to be generally in accordance with the existing development approval.

## **Background/Summary**

It is recommended that Council use section 130 of the Local Government Regulation 2012 in order to potentially save administrative costs in respect of rate payments received on 3 and 4 October 2018. The due date to show on issued rate notices is 2 October 2018.

#### The regulation says:

The local government may, by resolution, change the discount period to end 130 (7) on a later day (the new discount day).

However, if the discount period is changed under subsection (7), the local 130 (8) government must also, by resolution, change the due date for payment to a later day that is no earlier than the new discount day.

Subject: Proposed dedication of Glamorgan Vale Council lots as road

## **Background/Summary**

Council freehold vacant lots are subject to State Government levies and there are other potential implications with holding land in freehold title.

Lot 11 RP35597 and lot 12 RP35597 in Glamorgan Vale are shown as "extreme" flood hazard land on Council mapping. Both lots occupy 1,012 square metres.

While Council has sold small freehold titles in rural areas to neighbouring property owners previously to help facilitate potential boundary realignments by the neighbours, it is noted that the adjoining land in this case is also flood hazard land and it is recommended that the two lots be converted to road to manage Council's future costs and risks.

Subject: Transfer of dog registration from other local government areas

## **Background/Summary**

Council has for many years by practice been allowing the transfer of dog registration from other local authorities when new residents relocate to the Somerset Regional Council area.

The background for allowing this transfer of registration from other local authorities is not clear.

It is noted that other local governments do offer reciprocal dog registration and the recommendation below paraphrases a section of the Ipswich City Council schedule of cost recovery fees. It is considered that there are benefits in allowing reciprocal dog registration for new Somerset residents.

#### General activities and key projects undertaken

A listing of key events and projects with a brief summary is outlined below. Please note that there may be other events or activities not included.

 The YEO distributed the minutes for the Toogoolawah State High School (TSHS) Support Services Meeting and has continued to liaise with relevant stakeholders regarding items raised at both this meeting and the equivalent meeting held at Lowood State High School (LSHS).

The YEO scheduled a support services expo at Kilcoy State High School (KSHS) on 24 July which was attended by the CDC. The event was held during the school lunch hour, in conjunction with a free barbecue, to raise awareness of support organisations available to youth in the Kilcoy area. Services provided information, giveaways and activities for students. Feedback from the event suggests that the event was successful and that further opportunities would be welcomed in the future. The YEO is now awaiting confirmation from the school regarding stalls and bubble soccer suit use at the Open Day event scheduled for September.

- The YEO has confirmed the booking with the Sunshine Coast Recreation Centre (SCRC) for Monday, 21 January 2019 to Wednesday, 23 January 2019 for 30 students and three staff. YEO will continue to liaise with the schools regarding student selection and further camp details, and to develop Council inclusions into the camp program.
- The YEO met with a representative of the Kilcoy Lions Club Inc, Councillor Cheryl Gaedtke and Councillor Helen Brieschke (representing the Toogoolawah Progress



Association) to discuss the next two screenings for the Kilcoy Flicks Nights. It was determined that the next movie would be aimed at a family audience, with youth also being offered the opportunity to assist with the evening, and that it would be scheduled for 11 August at 5pm. The final screening will be held in October and youth will be encouraged to support this evening through movie selection, choice of theme (potentially Halloween) and assistance at the event. The YEO will continue to work with the Kilcoy SHS chaplain and other relevant stakeholders to encourage youth to get involved.

- The Winter School Holiday Program for 2018 took place during July with good attendance reported from various stakeholders. The YEO assisted in some set up for the Somerset Rail Trail Fun Run and Ride and liaised with various community members regarding activities.
- The YEO volunteered at the third annual Regional Youth Mental Health Forum, Talkin' It Up, at USQ Ipswich on July 26. This forum aims to raise youth awareness about the mental health support available, reduce the stigma surrounding mental health and to help students gain confidence in assisting their peers to access support services. Schools from across the Ipswich and West Moreton area are able to invite 30 students each to register for the forum; both TSHS and LSHS attended this year. The Somerset region hosted the first forum in 2016 and has the opportunity to host the event again in 2019.
- The YEO continued to post to the Somerset Youth Facebook page. Posts to this
  page have included posts regarding programs and activities available for youth and
  families, such as the Winter School Holiday Program 2018 and Kilcoy Flicks Night, as
  well as various other events, opportunities and Council initiatives.


## 1. Operate Indoor Sports Facilities

## Fernvale Indoor Sports Centre

• There were 1,867 attendees at the centre in May. Attendances were lower than figures recorded in the previous month, however is higher than the same time last year as highlighted by the table below.



- Gym memberships for May were slightly lower than figures recorded in the previous month, however higher than figures recorded during the same period last year.
- Internal marketing included keeping the facebook page updated with regular posts, the

  sports available to members on the VMO screens inside the facility.
- External marketing included offering new members for only \$10.00 for the first month instead of paying the normal rate of \$14.50 per week. This represented a saving of \$48.00

#### Toogoolawah Community Gym


- Attendances in May were slightly higher than figures recorded in the previous month.

## Kilcoy Indoor Sports Centre and Gym

Subject: State Penalty Enforcements Registry (SPER) Codes

#### **Background/Summary**

Correspondence has been received from the Department of Agriculture and Fisheries advising that a number of new PINs have been recently prescribed in the State Penalties Enforcement Regulation 2014, for offences under the *Biosecurity Act 2014*, the Biosecurity Regulation 2016 and the *Animal Management (Cats and Dogs) Act 2008*. The new PINs relate to requirements for restricted matter; restrictions on animal feeding; registration requirements; compliance with directions; certification and audit requirements; specific breaches of the general biosecurity obligation in relation to invasive biosecurity matter and the management of cats and dogs.

A review of Council's State Penalty Enforcements Registry (SPER) Codes has been undertaken for the specified legislation, with reference to the State Penalties Enforcement Regulation 2014. This Regulation includes infringement notice offences and fines for nominated laws that can be enforced by Council.

As a range of further offences for which Council may issue infringement notice offences and fines have been created via the legislation, it is recommended that Council endorse changes to the State Penalty Enforcements Registry (SPER) to create the offences listed in Attachment A. Council are unable to take enforcement action until a SPER Code for the particular offence is registered with the State Penalties Enforcement Registry.

Subject: Cleanaway Kerbside Recycling - Kilcoy Area

## **Background/Summary**

Council enquired from our kerbside recycling contractor for the Kilcoy area on 8 May 2018 about the present status of recycling. Following this enquiry by Council, a letter was received on 18 May 2018 from Cleanaway Pty Ltd advising that they had no concerns in the foreseeable future with the acceptance and processing of recycled material and nor had they received any notification to increase rates from Visy Paper Pty Ltd who Cleanaway contract to process recyclables.

On the 30 July 2018, Council received a further letter from Cleanaway advising that they had received correspondence from Visy on 6 July 2018 that rates will increase by \$35/tonne for kerbside recycling and Visy is unable to absorb the additional cost and will be passed onto Cleanaway.

A meeting was held on the 6 August 2018, with Council officers and Cleanaway management to discuss the impact of the above advice. Cleanaway advised that they have tried to negotiate with Visy about the increase in cost and unable to meet a resolution and forced to pay the additional cost of \$35/tonne. Cleanaway advised that in 2017, Visy increased rates by \$10/tonne which they absorbed. They are unable to absorb this further cost of \$35/tonne and hopeful to pass the additional cost of \$35/tonne onto Council. Presently, the tonnage of recyclables received is about 35 tonnes per month, increasing the cost by \$1,225 per month (or \$14,700 per annum). Presently, the total number of recycling services is 1,192, therefore equating to additional cost per service of about \$1.03 per month (or \$12.33 per annum). Cleanaway confirmed that extra cost would be determined and evidenced by weighbridge dockets.

Under the terms and conditions of the contract between Somerset Regional Council and Cleanaway Pty Ltd, there is no mechanism for Cleanaway to pass on these costs to Council. At the meeting, Cleanaway indicated their acceptance of this fact but remain hopeful that Council will partner with them in working through this unfortunate circumstance. Council is also advised that it is not possible to immediately pass these costs onto the ratepayer receiving this service.



In summary, Council may consider the following options:

- Advise Cleanaway Pty Ltd that it is not willing to accept the additional cost of \$35/tonne and refuse the claim per the terms and conditions of the contract. Council remains willing to partner with Cleanaway (non-cash) to find potential solutions to kerbside recycling within the Kilcoy area.
- Advise Cleanaway Pty Ltd that is willing to accept the additional cost of \$35/tonne with Council absorbing the cost. However, no further requests for increased rates will be considered. Council remains willing to partner with Cleanaway (non-cash) to find potential solutions to kerbside recycling within the Kilcoy area.
